THIS FORM IS FOR HIGH SCHOOL ENTRIES ONLY.

TYPE OF TOURNAMENT: Format is 4-player fixed-roster teams (minimum of 3 players to form a team). The tournament will be conducted using the “Swiss System” (no elimination –score determines final place). All teams will play all day.

ELIGIBILITY: Any accredited high school in Indiana may send any number of four (4) member teams to compete in the State Finals. (Up to three (3) alternates per team are allowed.) **Team members must all be full-time students at the same school building.** A parent or school sponsor should accompany the group to the competition.

USCF Membership: The State Finals will be rated by the U.S. Chess Federation. All participants must have current USCF membership (through at least March 31, 2010). **In order for the rating report to be submitted promptly, no player will be allowed to play on March 27 without USCF membership.** Include USCF fees with your entry form if necessary.

IMPORTANT RULES:

1. All divisions in the Finals will be four-member teams. (Up to 3 alternates are allowed per team.) (A minimum of 3 players is required to form a team, forfeiting 4th board.)
2. **A student may play only for the school that he/she attends full-time** and may play in only one division.
3. A team must rank all of its players according to ability. (This includes alternates. If there are 7 players on the team, all 7 players must be listed in strength order.) (See page 4 for details on alternates.)
4. The tournament will be divided into four divisions: 12th Grade & Under, 8th Grade & Under, 6th Grade & Under, and 3rd Grade & Under. **(This entry form is for 12th Grade & Under only.)**
5. 12th Grade & Under Rule: Students participating in the 12th Grade & Under division will NOT have qualifying regionals. All competition for this division will be held at Honey Creek MS in Terre Haute on Saturday, March 27, 2010. (Teams must still send in the enclosed entry form **with player roster and any necessary USCF membership fees**, postmarked no later than March 18, 2010.)

Please arrive by 8:30 A.M. (Eastern time). The players meeting will begin at 8:50 A.M. followed by the first round. Play will be continuous during the day.

Notes for March 27:

If your registration form was complete, you will find a packet for your team on the table near the entry to the playing area at Honey Creek MS – **check the attached roster for accuracy and team order. If players play out of board order, those games will be forfeited.**

Participation ribbons will be enclosed in your packet. If your packet is NOT there, please take care of problems at the table located outside the east gym (hallway outside the playing area.)

Your team will be assigned a table in the skittles area (west gym, hallway, or cafeteria). There are signs on the tables. (Make a note on the entry form if you need a table close to another school.)

The playing area is the east gym (smaller gym to the right as you enter.) The west gym (larger gym to the left) is reserved for team tables.

Mr. Thad Rogers (American Chess Promotions) will be set up with chess books and equipment for sale.

Food is available onsite, or you are welcome to bring in your own food (but please clean up your table/area at the end of the day.) No food in the playing area, please.

If teams are tied on match points, the tiebreaking procedures are as follows:

1. Game points
2. Modified Median
3. Solkoff
4. Cumulative

Time controls for 12th/Under: Game/40. If using a time-delay clock, set the **delay** to **ON**, with a 5-second delay. (**Sound** must be **OFF**.)

Please note the order of your players on your team roster. Your players **must** play in this order (strength order that you turned in.) If you have alternates (also listed in strength order), you are free to play any players you wish in any round, but they must stay in the listed order.

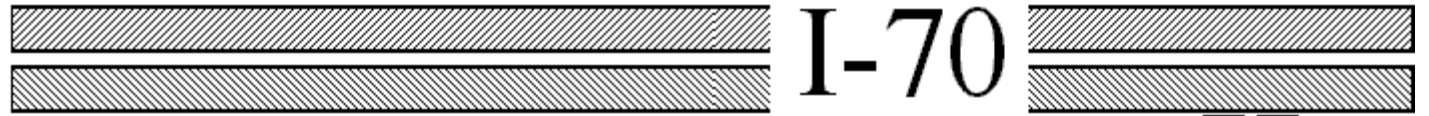
If players play out of the listed board order, those games will be forfeited.

All players on the team should sit on the same side of the table. If a team is listed as White on the pairing sheet, the 1st board player is White, 2nd board is Black, 3rd board White, 4th board Black. (Fill out all players' names on the **left** side of the round sheet.) Likewise, if the team is listed as Black, the 1st board player is Black, 2nd board is White, 3rd board is Black, 4th board is White (and you fill out all players' names on the **right** side of the round sheet.)

Captains are the only players allowed to stay when their game is completed. Stress to your players that they should stop their clock and raise their hand if they have ANY question concerning the game. (Questions must be initiated by the players.)

Adults are welcome to check on the games as long as you stay in the wider aisles (please don't hover over players' shoulders for a lengthy time, however.) No one should say anything about any games in progress. ("No kibitzing" applies to adults as well as other players.)
